- IAME USA West must have an active credit card on file for you to rent an engine.
- IAME's head engineer has overseen the SSE dyno break-in process for all engines. These motors will be race ready and every effort will be made to ensure an excellent quality race engine. Renter acknowledges these engines are used in high stress racing applications and no warranties are implied or given. Renter acknowledges IAME has no control over chassis issues, driver error, inclement weather, unforeseen track conditions, our outside catalysts which may affect performance.
- Any request for rental cancellation and/or refund must be submitted **in writing** to alexis@iameusawest.com no later than November 3rd 2019 at 11:59 PM (PST). No refunds will be granted on cancellations received after above deadline.
- Damage to the rental engine and/or excessive wear will be billed to the renter. This rental agreement covers normal wear and tear only. Damage not covered in this agreement is (but not limited to) abusive overheating, crash damage, excessive clutch wear, or other items deemed inconsistent with normal racing / operating activity.
- Missing or damaged parts from the supplied engine/accessory rental kit will be billed to the customer at prevailing prices.
- All engines and rental parts must be returned reasonably clean. If not, a nominal cleaning fee will be assessed. (*to be determined by IAME mechanics, depending on particulars.)

- I have been made aware and understand there are factory employees here to help me with questions and concerns:

 - IAME USA West's SSE technician (George Tavares)
 - IAME USA Technical Director (Lynn Haddock)
 - IAME SPA Technical Director (Andrea Bossaglia)
 - Tillotson representative (Andrew Fallon)
- Renter acknowledges they are aware of the above help on-site and are encouraged to check in, *even if everything is seemingly fine.
- Renter agrees to allow IAME to help diagnose and troubleshoot any major issues. Renters are strictly forbidden from splitting cases or opening / examining the internals of any rental engine without the express permission of an authorized IAME representative. Any damage(s) caused by failure to abide by this clause will be the sole responsibility of the renter.
- All engines **must** be returned to IAME or paid for in full (if renter intends to keep) by Sunday November 24, 2019 following the last main event of SuperNationals 23. Any engines not returned will be assumed to be purchases, and renter agrees to pay the remaining balance to complete the sale, using the card on file.
- Renter assumes sole responsibility of rental engine until IAME USA's George Tavares completes return process with renter and signs off on any potential issues or concerns.
